## Crime in Focus: What's Happening on the Ground?

Zimbabwe remains one of the most crime-affected countries in Africa, currently ranked 7th in the continent and 25th globally in terms of crime rates. The numbers tell a concerning story—a 45% rise in crime in early 2023 was followed by an 11% increase from January to August 2024. Armed robberies, cross-border smuggling, and home invasions are among the most reported crimes, showing that criminals are not slowing down.

#### The Masvingo Heist – A 345-Year Sentence!

This is exactly what happened in Masvingo this month, where a gang of three robbers terrorized businesses and homeowners, often attacking in the early hours of the morning. Their reign of terror came to an end when authorities arrested them and handed down a combined **345-year prison sentence.** 

This case highlights a crucial point—criminals are becoming more structured in their approach, operating in networks, and scouting their targets carefully. Many victims reported that they felt watched in the days leading up to the attack. Could it be that criminals are studying their victims before striking?

**Tip:** Always be aware of unfamiliar faces near your home or business. If someone seems to be loitering or taking too much interest in your routine, report it immediately.

#### Smuggling Gone Wrong – R14 Million Seized!

Zimbabwe's borders have always been hotspots for criminal activity, and this month was no different. On January 18, 2025, authorities intercepted a smuggler attempting to move R14 million worth of illicit cigarettes into South Africa via the Beitbridge Border Post. This is one of the largest cigarettes smuggling cases recorded in recent months, exposing the growing black-market trade that thrives in Zimbabwe.

What's worrying is that this is not an isolated incident. Smuggling is not just limited to cigarettes—it includes gold, fuel, and even stolen vehicles. Criminal networks often have local contacts who help them evade detection, meaning that some of these criminals are hiding in plain sight within our communities.

This trend raises serious security concerns, especially for businesses that employ temporary or casual workers without thorough vetting.
